How many solar modules have been added in 2024?

Since the IRA's passage, more than 95 GW of manufacturing capacity have been added across the solar supply chain (from facilities announced pre- and post-IRA), including nearly 42 GW of new module capacity. U.S. c-Si manufacturers added significant capacity in the first half of 2024.

Which companies are concerned about the new solar law?

Five solar manufacturing companies - T1 Energy (TE.N),Imperial Star Solar,SEG Solar,Solx and ES Foundry-said they are also concerned about the new law's impact on future demand,but that they have not changed their investment plans.
