

## Bosnia and Herzegovina photovoltaic energy storage exports

Why is Bosnia & Herzegovina's energy sector so vulnerable?

This delay persists despite the ENTSO-E cybersecurity report from 2022, which identified Bosnia and Herzegovina's energy sector as one of the most vulnerable in the region due to outdated infrastructure and insufficient cybersecu-rity investments.

Who is building a 125 MW solar plant in Bosnia & Herzegovina?

Bosnia and Herzegovina has started working on a 125 MW solar plant - its largest to date. China's Norinco Internationalwill build the facility, with completion expected in one year. The European Commission has published a call for private companies to invest in the Western Balkans.

Should Bosnia and Herzegovina transpose the natural gas acquis?

Bosnia and Herzegovina should transpose the natural gas acquis in the entire territoryand implement the network codes. It should open its market. Bosnia and Herzegovina should transpose and implement the required elements of the EU ETS Directive, including the Monitoring and Reporting Regulation and the Accreditation and Verification Regulation.

Does Bosnia and Herzegovina provide security of electricity supply statements?

Bosnia and Herzegovina is notproviding the Security of Electricity Supply Statements to the Secretariat despite its obligation under Article 29 of the Treaty.

How many companies operate the gas Trans-mission system in Bosnia and Herzegovina?

Three companies Bosnia Herzegovina operate the gas trans-mission system. In the Federation of Bosnia and Herzegovina, one company operates the transmission network as an exclu-sive and sole task in line with the Decree on Organisation and Regulation of the Gas Sector, but there is no legal basis for unbundling under the Third Energy Package.

Is there a peci project in Bosnia and Herzegovina?

There is no PECI projectin the territory of Bosnia and Herzegovina, chosen un-der the procedure launched in 2024 for the Energy Community which relates to gas or hydrogen.
