Why should you follow USPS rules on lithium ion shipments?

Batteries--especially lithium-ion--pose fire or explosion risks if mishandled during transit. Following USPS rules protects your deviceand ensures you comply with federal and international regulations governing hazardous goods shipments. USPS follows federal hazardous materials regulations for transporting batteries. Key requirements include:

How do I ship a lithium battery?

Use strong packing tapeto reinforce all seams. If shipping lithium batteries separately, affix appropriate hazmat or battery markings according to USPS guidelines. Domestic shipping within the U.S. has fewer restrictions on lithium batteries installed in equipment.

How does USPS transport lithium ion batteries?

USPS follows federal hazardous materials regulations for transporting batteries. Key requirements include: Lithium-ion batteries must be shipped to prevent short circuits,damage,or accidental device activation. Batteries must be securely packed--usually inside the device or separately,with protected terminals (taped or capped).

Do I need a specific lithium battery Shipping Class?

FedEx Ground strongly recommends that anyone shipping lithium batteries take a specific lithium battery shipping class in order to better understand these complex regulations and meet DOT/ICAO/IATA/IMDG/USPS requirements.

Can a battery be mailed?

Multiple cell batteries inside the housing or casing exceeding 100Wh for each battery are nonmailable. Damaged/recalled individual batteries are prohibited and need approval. Domestic shipping via air: Maximum 8 cells or 2 batteries with or installed in the new or Manufacturer Certified Refurbished (MCR) equipment in the same package.

Can I ship batteries with USPS?

Let's simplify the process and make shipping batteries with USPS hassle-free. The short answer is yesbut with strict conditions. USPS battery shipping allows you to ship it under certain conditions, but there are still some types of batteries that cannot be shipped. The following introduces nonmailable and mailable situations:

When improperly handled, packaged, or stored, batteries pose a risk for corrosive chemical and electrical fires. Emphasis must be placed on safety when packaging and transporting them. ...
