How much does a project cost in Italy?

Eligible projects should have an estimated cost of up to EUR 1 million, with the minimum being EUR 30,000. The funds will be drawn from Italy's recovery and resilience plan, with around 40% to be reserved for projects in the regions of Abruzzo, Basilicata, Calabria, Campania, Molise, Puglia, Sardinia and Sicily.

How much money does the Italian government give to SMEs?

(EUR 1.0 = USD 1.051) The Italian government has signed a decree to allocate EUR 320 million(USD 336.3m) in state funding to small and medium-sized enterprises (SMEs) willing to install self-consumption wind or solar power plants.
