Tariffs on Polish PV module exports

Where can US exporters get information on Polish tariffs?

U.S. exporters seeking to enter the Polish market can obtain useful information from the Office of European Union at the U.S. Department of Commerce. The Polish Customs Service (Sluzba Celna) has an official Tariff Browser (a module of the Integrated Tariff System - ISZTAR), that provides information on tariffs of goods in international trade.

What are Poland's tariffs based on?

Tariff classification Poland adheres to the General Agreement on Tariffs and Trade (GATT) and tariffs are based on the Harmonised System. Polish customs regulations comply with the European Union's European-wide directives.

How do trade policies affect solar PV deployment?

As governments worldwide accelerate their transition to renewable energy, the role of trade policies in determining the successof solar PV deployment has become more pronounced, making it essential for industry participants to develop comprehensive strategies that account for evolving regulatory frameworks and market conditions.

What data does the tariff browser contain?

The Tariff Browser contains data from the TARIC system(goods nomenclature,duty rates,restrictions,tariff quotas,tariff ceilings,and suspensions) as well as national provisions (VAT,excise tax,restrictions,and nontariff measures).

Will bifacial solar panels be exempt from tariffs?
