Uzbekistan is not a party to the WTO Agreement on Government Procurement and is not a party to a free trade agreement (FTA) with the United States. U.S. companies bidding on Government tenders may also qualify for U.S. Governmentadvocacy.

How do I get support for a project in Uzbekistan?

Advocacy assistancecan take many forms but often involves the U.S. Embassy or other U.S. Government agencies expressing support for the U.S. bidders directly to the foreign government.
